**5. Public Comment on matters not on Today's Agenda** (2 minutes per comment)

No public comment.

**6. Presentation** (Discussion and Possible Action)

a. District Attorney's Office

i. Presenters: Jean Roland and Tiffany Sutton, District Attorney's Office

Jean Roland and Tiffany Sutton gave a budget presentation.

Officer Valencia-Tow asked what their current policies are around charging youth as adults, to which Roland said they look at the criteria of the case in question to see whether or not they're transferable based on specific codes, and they invite

input to make a case for or against charging minors as adults. Roland said they take those recommendations to the District Attorney and make a final decision. Valencia-Tow asked if they consider the impacts on youth being tried as adults during those discussions, to which Roland said yes.

Officer Liang asked if diversion programs address the crimes and reduce rates of recidivism based on the data, to which Roland said she doesn't have the exact numbers but that they know those who were diverted instead of tried showed a huge reduction of recidivism. Roland asked for the Commission to advocate for continuing this funding. Liang asked if they know how many fewer people they would be able to serve through this program if their budget request isn't fulfilled, to which Roland said reductions in funding means cutting staffing, and that would mean making a decision on if they can afford the program at all.

Officer Fong asked if the current budget of this program serves the full capacity of what they need, to which Roland said they serve about 20 youth every year and don't have any issues turning away youth. Fong asked where Community Works West (CWW) gets their money from, to which Roland said CWW get their funding from DCYF and are based in the East Bay. Roland said they serve youth from the counties of San Francisco, Alameda, and Contra Costa.

Vice Chair Listana asked if the resources included in these programs are only within the District Attorney's Office, to which Sutton said they are mainly referred towards CBOs and outside of the DA's Office since they know they can't do it alone and want to work with the community. Listana asked if all the funding comes from City grants, to which Sutton said they receive all of the funding for this program from the Human Rights Commission (HRC). Chair Fong asked if they go through the RFP process, to which Sutton said they do not since that's for the community, but they request it directly from HRC based on their needs.

Officer Liao asked if there's data on the effectiveness of this program, to which Sutton said they don't have data yet, but they do measure the program in the hope that it gives the youth that they work with. Liao asked what the outreach looks like to recruit youth into their office, to which Sutton said they work with CBOs that focus on violence prevention and work with justice-impacted youth, and they participate in various community engagement opportunities.

Officer Valencia-Tow asked what factors could heighten a youth's chances of being sent to an adult court, to which Roland said they can't say if it's a single factor since it's a case-by-case situation with unique circumstances for the youth and crime in question. Valencia-Tow asked if the victim has any say in whether or not the youth faces adult court or not, to which Roland said not necessarily, but that the victim can inform with any details that the District Attorney's Office will then discuss further independently.

b. Climate Action Plan

i. Presenter: Elizabeth Stampe, Senior Climate Action Coordinator

Elizabeth Stampe gave a presentation on the updates to San Francisco's Climate Action Plan.

Commissioner Fortgang asked if they see climate literacy as a part of climate action, to which Stampe said yes and they're focusing on education. Fortgang asked how the Youth Commission can support the Climate Action Plan, to which Stampe said direct input and sharing it with their peers would be helpful.

Commissioner Lonné Amir asked where the funding comes from to go towards the Climate Action Plan, to which Stampe said it's complicated because it goes across multiple departments and each of them address their respective sections of the action plan themselves. Stampe said they're adding a funding aspect to the plan since it's not entirely funded.

Commissioner Ansari asked about what feedback they've heard from the 2021 plan to better inform the 2025 plan, to which Stampe said she wasn't present during the time that the first plan was written but that there are several factors: political feasibility of legislation, funding, etc.

Officer Yang asked about how youth workforce development will be reflected in the Climate Action Plan, to which Stampe said the building inspection has the most fleshed out answers of how youth can be part of workforce development.

Officer Valencia-Tow took a point of personal privilege at 5:53pm, and returned at 5:55pm. Commissioner Kim took a point of personal privilege at 5:54pm, and returned at 6:01pm.

c. K2C & CalKIDS Update

i. Presenter: Mohan Kanungo, K2C Program Manager

Mohan Kanungo gave a presentation on the City's K2C (Kindergarten to College) program, as well as the State's CalKIDS program.

Commissioner Dang asked what outreach methods they have to let students know they have these funds available, to which Kanungo said the best method is for students to talk to their peers about it, but they are committed to doing regular communications for graduating students and workshops to educate students how to access their funds.

Chair Fong called for an 8-minute recess at 6:31pm, and called the meeting back to order at 6:40pm.
