By helping address these issues, the SFMTA's Next Generation Customer 4 Information System will undoubtedly improve the travel experience for San Francisco youth. 5 6 The Youth Commission is a body of 17 young people between the ages of 12 and 23. Created by the voters 7 under a 1995 amendment to the City Charter, the commission is responsible for advising the Board of 8 Supervisors and the Mayor on policies and laws related to young people. The Youth Commission is also 9

charged with providing comment and recommendation on all proposed laws that would primarily affect youth
before the Board takes final action. To meet their charter duties, the Youth Commission works closely with
city departments on projects and programs that serve youth, including the SFMTA. Transit accessibility has
remained a top priority for the Youth Commission over its 21 year history.
