About Us

The San Francisco Youth Commission is a body of seventeen young individuals appointed by the Board of Supervisors and the Mayor of San Francisco. Under Section 4.124 of the City Charter, we are responsible for advising the Board and the Mayor on the 'effects of legislative policies, needs, assessments, priorities, programs, and budgets concerning the children and youth of San Francisco.'

In 1995, community members lobbied City Hall to develop a resolution that would create a Youth Commission in San Francisco. This piece of legislation originally failed at the Board of Supervisors. Then-Supervisor Angela Alioto subsequently sponsored a Charter Amendment that out the question whether or not to create the Youth Commission to the voter of San Francisco.

In turn, Proposition F won 60% of the votes on the November 1995 ballot, and the Youth Commission was created! The first class of commissioners was sworn into office in April 1996. We are currently in our 27th year of existence!

The San Francisco Youth Commission also has the duty to provide the Board of Supervisors and the Mayor with "comment and recommendation" on all proposed laws "that primarily affect the children and youth" of San Francisco. We are charged with identifying the "unmet needs" of youth through a variety of methods.

These include researching existing government and private programs and sources of funding for such programming, holding public forums, and working with existing youth groups and advocacy organizations. Each year, the commission provides the following: comments and recommendations on pieces of proposed legislation referred to the commission; resolutions and motions that formally articulate our positions and requests on various youth-related issues; and a set of policy priorities to guide the City's annual budget process as it relates to young people.

Executive Summary

The San Francisco Youth Commission ("the Commission") has fulfilled its chartered duties by advising the Board of Supervisors and Mayor's Office on the best ways to address youth issues in San Francisco. The commissioners worked diligently with staff, community partners, and departments to ensure the San Francisco Youth Commission was being the best advocate for youth across the City and County of San Francisco.

The San Francisco Youth Commission faced several uphill battles this year: major budget cuts to youth serving initiatives, elected office transitions, balancing school work and commission responsibilities, and ensuring they communicated and worked with community partners on expansive issues impacting youth.

The San Francisco Youth Commission in their Annual Report revealed the different ways they worked through different perspectives to ensure they met their chartered duties to address youth issues in San Francisco. Over the last year, the Youth Commission has worked on strengthening its advocacy arm and working with different organizations who are boots on the ground working with youth directly.



Committee Report Back

The San Francisco Youth Commission has three standing committees where the majority of the work and conversations occur.

They meet twice a month and have encouraged members of the public to come attend and participate at the committee meetings.

During the 2024-2025 Youth Commission term, the San Francisco Youth Commission expanded on advocating on new issues affecting youth and ensured they worked on addressing these issues during budget season.

They also included community presentations at the committee meetings.

The Civic Engagement and Education Committee (CEEC) tackled a variety of issues during its 2024 - 2025 term, including school safety, food insecurity, youth development programs, and many others.

School Safety

Similar to the previous years, CEEC approaches school safety from similar fronts: safety infrastructure and community and student engagement.

Over the past few years, the Committee has recognized that SFUSD has been slowly implementing some safety infrastructure mechanisms, but it's still not at the speed at which students feel safe.

School Safety Cont.

The Committee also recognizes that the District has been faced with some of its issues, such as the ongoing fiscal crisis which comes with possible school closures and mergers. However, with the passage of Proposition A in 2024, the Committee urges the Board and the Mayor to collaborate with SFUSD to quickly implement the safety mechanisms and to modernize plumbing and infrastructure. The Committee also asks all the stakeholders to include student input in these conversations. Resolution No. 2425-AL-O7 was passed by the Commission to address the issue.

In the 2024 - 2025 Budget and Policy Priorities Report, the Committee calls for better oversight of SFUSD's school safety infrastructure upgrades, effective use of the Proposition A spending plan to see through the upgrades, and establishing better communication channels between students, the administration, and the Board of Education.

Food Insecurity

In recent years, in response to students and other SFUSD community members have repeatedly expressed concerns about the quality of Student Nutrition Services' nutrition programs. The San Francisco Youth Commission has consistently advocated for increasing support for city-funded food programs in alignment with this strong youth sentiment. Making high-quality school meals more accessible over longer hours and across all SFUSD schools is vital to sustaining student health and future success in schools.

Civic Engagement and Education Committee

Food Insecurity Cont.

In the 2024 - 2025 Budget and Policy Priorities Report, the Committee calls for SFUSD to restore the School Food Advisory Program, integrating student feedback on school meals, continuing to address increased food insecurity over school breaks, and increasing supplemental food provided in SFUSD schools.

Additionally, during the budget negotiation process, the Youth Commission advocated for restoring funding to the Sugary Drinks Distribution Tax fund that is dedicated to addressing food insecurity and health disparities in low-income communities of color, while asking for transparency from the Board and the Mayor's Office on how the funds would be spent when it's moved from the Department of Public Health to the Human Services Agency.

Youth Development Programs

Since the most recent Department of Children, Youth, and their Families (DCYF) Request for Proposal (RFP) process was finalized, many DCYF-funded programs were unable to operate to their maximum capacity due to a reduction or elimination of their funding. Since then, the Committee has consistently advocated for increased funding to DCYF so that these programs can effectively serve all youth.

The Committee believes that community-based organizations (CBOs) and school wellness centers have long been an important cornerstone of student well-being and development.

Civic Engagement and Education Committee

Youth Development Programs Cont.

CBOs that partner with schools to offer on-campus services are often the most accessible for students. In San Francisco's current fiscal climate, many services directly impacting youth, including those that provide in-school support, are at risk of budget cuts. This severely curtails their ability to support youth across the city.

Additionally, wellness centers were implemented in San Francisco Unified School District (SFUSD) schools to make mental and physical health care services readily accessible to all students and to cultivate a sense of safety and belonging. During the pandemic, the need for mental health services skyrocketed among youth. Now, these centers have grown to be one of the most important services offered on campus. Serving 16,000 public high school students across 19 SFUSD campuses, the centers act as one of the most accessible places for getting comprehensive support from licensed staff.

In the 2024 -2025 Budget and Policy Priorities Report, the Committee calls for securing consistent funding for Community-Based Organizations that work directly with schools to support youth, and for SFUSD to allocate more funding for SFUSD Wellness Centers.

Budget and Policy Priorities

CEEC proposed five (5) Budget and Policy Priorities (BPPs) for the 2025-2026 / 2026-2027 City Budget. These 5 BPPs included Vote16 and Youth Civic Engagement, Addressing Food Security, Youth Development Programs, Addressing Sexual Violence Amongst Youth, and Social Isolation. The Youth Commission's Housing, Recreation, and Transit Committee (HRT) focused on a variety of issues during the 2024/25 term, such as housing, youth/transitional-aged youth homelessness, youth-friendly public recreational spaces, street safety initiatives to protect pedestrians and cyclists, and environmental initiatives to address climate change.

Housing

Within the issue area of housing, the HRT Committee prioritized affordable housing, rent control, tenant protections, attention to single-room occupancy units (SROs), zoning laws, and youth/transitional-aged youth. Commissioners heard a presentation on Bay Area Community Resources (BACR)'s smoke-free housing policy proposal, as well as took action on housing issues by passing resolutions in support of smoke-free housing (Ansari, Fortgang, Valencia-Tow, Krehlik, Oram, Liao), in support of AB 1157 - the Expanding Tenant Protection Act (Valencia-Tow), in support of SF Planning's 2025 Expanding Housing Choice Plan (Valencia-Tow), and in support of Expanding Family Shelter Options (Valencia-Tow).

Housing, Recreation, and Transit Committee

Recreation & Climate

Within the issue area of recreation and climate, the HRT Committee prioritized improving local parks and community spaces, climate literacy and education, protection against sea-level rise, green appliances in new housing, implementing electric vehicle charger legislation citywide. Commissioners heard a presentation on CalAcademy's Careers in Science Internship Program, as well as passed resolutions in support of EV Charger Implementation (Fortgang, Yang, Liao), and in support of Strengthening Climate Literacy in SFUSD to Activate Youth to Take Climate Action (Fortgang, Lonne Amir, Marlow, Oram, Valencia-Tow, Liang, Fong, Listana, Liao, Yang, Alameri, Kim, Dang, Ansari).

Transportation

Within the issue area of transportation, the HRT Committee prioritized the Free MUNI for All Youth program, expanding free transit youth access to BART and Caltrain, safer bike lanes, extending bus routes to accommodate more riders, making schools more transit accessible, equitable access to the Presidio National Park, addressing vision zero, and increasing frequency for SFMTA's school trippers. Commissioners took action on transportation by passing resolutions in support of Extending the 24 MUNI Line (Oram), as well as in support of Lowering Speed Limits on Alemany Blvd, and the 19th Ave & Junipero Serra Blvd Intersection to Reduce Pedestrian/Vehicle Collisions (Ansari).

Housing, Recreation, and Transit Committee

Budget and Policy Priority Areas

The HRT Committee proposed the largest number of BPPs of any Youth Commission committee, with 5 expansive priorities that included subpriorities within them. These priorities include: (1) Free MUNI for All Youth; (2) Street Safety & Vision Zero; (3) Expand Reliability & Access to Transit; (4) Expanding Recreational Spaces; (5) Equitable Housing Assistance for Youth & TAY; (6) Climate Resilience; (7) SROs, Rent Control, and Tenants Rights; (8) Climate Literacy & Action; and (9) Affordable Housing. Equitable Housing Assistance for Youth & TAY, SROs, Rent Control, Tenants Rights, and Affordable Housing BPPs were consolidated under a singular 'Housing BPP'. The Free MUNI for All Youth BPP was consolidated under the Expand Reliability & Access to Transit BPP. During and after the City's budget process, Youth Commissioners successfully advocated for restoring funding to assist SRO tenants living in poor conditions, held a joint meeting with SFMTA and other youth leaders to prioritize youth transit initiatives (i.e. FMFAY, discounted programs), and expanding SFMTA's school trippers to ensure students get to school and home on time, both of which fell under the advocacy of issues that the HRT Committee prioritized.

The Youth Commission's Transformative Justice Committee (TJ) focused on a variety of issues during the 2024/25 term, such as language access, immigration support, essential food access in communities of color, reducing weapons access, and teen dating violence awareness.

Teen Dating Violence Awareness Month

Within the issue area, the Transformative Justice Committee worked with Black Women Revolt and Asian Women Shelter to advocate on addressing teen dating violence in San Francisco. We worked closely with community partners to write a motion recognizing the month of February as Teen Dating Violence Awareness Month. The commissioners and community partners made sure to do research and gather data that would support addressing this issue.



We recognize that the data on teen dating violence has increased and there's no investment in addressing the issue.

Transformative Justice Committee

Once the commission approved the motion, we worked to get the Board of Supervisors to recognize Teen Dating Violence Awareness Month. We also scheduled a meeting with Assemblymember Stefani to talk about the many hurdles to address teen dating violence and supported the state recognition of the awareness month.

Immigration Support

Within the issue area, the commissioners wanted to address the increased threats from the federal government to immigrant communities across California, but especially in San Francisco. Commissioners wrote a resolution requesting for the Mayor and Board of Supervisors to prepare more adequately when it came to protecting immigrant families.

Commissioners have seen the threats against the immigrant community affecting youth at schools and have not seen any reassurance to support immigrant families and youth. Due to ongoing litigation, the commissioners had delays on finding ways to advocate for immigration support. The commissioners requested the Office of Civic Engagement and Immigrant Affairs to present to the commission to ensure commissioners and youth had all the updated information on the current work the City and County of San Francisco is doing to protect and stand with immigrant families.

Transformative Justice Committee

Human Trafficking

Within the issue area, the Transformative Justice Committee in partnership with Black Women Revolt and Asian Women Shelter worked on a motion to recognize Human Trafficking Prevention Month and to ensure proper advocacy is continued to address this issue. Commissioner stressed that youth is the top demographic impacted by Human Trafficking and to find ways to support youth who are most vulnerable to ending up in human trafficking in San Francisco. The commissioners also advocated for additional funding sources for programs addressing human trafficking and supporting youth who have been exposed to trafficking. The committee also met with the Department on Status of Women to request further data points and find ways to collaborate on the issue.

Reducing Weapons Access

Within the issue area, commissioners in the committee worked on a budget and policy priority and resolution to reduce weapons access amongst youth in San Francisco. Throughout the year, the commissioners heard news headlines of guns being used at schools across San Francisco, including one of our commissioner's schools going on lockdown because of a gun threat. The commissioners urged the Mayor and Board of Supervisors to address the issue of gun access. The commissioner supported efforts at the state level to make access to guns more hard and to ensure safety in the home of a gun owner with a child. Some commissioners are connected with organizations like United Playa's and Pierce's Pledge to continue advocating in reducing weapons access and making San Francisco a safe place for all children.

Transformative Justice Committee

Budget and Policy Priority Areas

The TJ Committee proposed four BPP's to be issued in the 24-25 and 26-26 San Francisco Youth Commission Budget and Policy Priorities Report. These priorities include: Protections for Undocumented and Newcomer Families and Youth, Workforce and Youth Employment Program Access, Improving Police and Judicial Relations with Youth, and Violence Prevention. All of these topics covered are longtime advocacy efforts from the Transformative Justice Committee. Many of these issues have evolved since the pandemic and the recommendations have been adjusted to reflect the evolving issues in San Francisco affecting youth. Youth Commission in Action



This year, the San Francisco Youth Commission participated in various events and activities, amplifying youth voices across the City and County of San Francisco.

Annual Budget and Policy Priorities Advocacy

In accordance with the annual Budget and Policy Priorities that the Commission passed in March 2025, and in response to the budget proposals released in June 2025, the Commission focused on three budget items:

Restoring Funding for General Civil Legal Services

With the ever-changing situation impacting non-citizens in San Francisco, the Commission recognized the importance of providing services for non-citizens, especially for youth and their families. One of these services is free or affordable multilingual legal services for non-citizens. There are a number of non-profits that provide this type of competent and effective legal aid for the impacted communities, and the Commission worked in alliance with the non-profits to advocate for their budget add-back request of \$4.2 million for the next two fiscal years.

Sugary Drinks Tax Community Engagement Program

For the past two years, the Commission has recognized the importance of addressing food insecurity amongst young people, especially for young people living in communities with food deserts. The Sugar Drinks Tax has historically provided grants to non-profits that work to address food insecurity and provide community engagement programs to improve dental hygiene in low-income and food desert neighborhoods, such as for the Pacific Islander community in Sunnydale and Bayview. The Commission has worked to understand the issue and uplift their add-back request. With the complex nature that was proposed for the Sugary Drinks Tax, the Commission is still working to understand how the changes may impact these communities. In the meantime, the Commission worked with community organizations to push the Board of Supervisors and the Mayor's Office to approve a one-time addback amount of \$320,000 for the sugary drinks tax community engagement program for marginalized and underserved communities.

Transitional-Aged Youth Trafficking Prevention

The Commission has recognized for years that trafficking not only impacts adults, but also transitional-aged youth, and amongst the group, LGBTQIA+ TAY youth have often been the most vulnerable group that stays in the cycle of abuse. In recent years, the Commission has recognized the important work of Freedom Forward and the HYPE Center, which have provided valuable resources for at-risk youth to prevent the cycle of trafficking and abuse. During the budget cycle, the Commission worked with the organization to advocate for funding to continue their programming and drop-in center. The Board of Supervisors and the Mayor's Office ultimately approved a one-time addback amount of \$250,000 for the continuation of the multi-service drop-in center to prevent trafficking among transgender transitional-aged youth.

Community Partners

The San Francisco Youth Commission has over 300 different community based organizations as partners.

Throughout the 2024-2025 year, the San Francisco Youth Commission focused on establishing stronger relationships with community groups. Here are some honorable mentions:

The **HYPE Center** (Helping Young People Elevate) is a youth-focused, drop-in center for people ages 14–24. It's a low-barrier, multi-service hub co-designed by young people, offering access to mental health care, legal help, housing navigation, basic needs (showers, food, laundry), and peer support.

HYPE was created with input from youth who have experienced homelessness, exploitation, or trauma, so its services and space are especially tailored to support vulnerable young people.

Black Women Revolt is a San Francisco-based grassroots organization dedicated to supporting Black women and their families who have experienced domestic abuse. They provide culturally sensitive services including: case management, legal assistance, support groups, and youth prevention education.

They also run community-building events like a survivors' retreat to foster healing, empowerment, and connection. Black Women Revolt was founded in 2021 by Black women activists in SF, with a mission grounded in raising awareness about intergenerational violence in the Black community and creating a space specifically for Black survivors.

The APA Heritage Celebration Committee is a group of community representatives and organizations that put together the annual San Francisco celebration of Asian American & Pacific Islander Heritage Month. As part of the 2025 celebration theme "Energizing the Next Generation," Chair Fong and Vice Chair Listana were to work with the committee and a group of young leaders who selected the 2025 AAPI Youth Change Maker Honorees.

Youth Commission Impact
