10	fear of accessing basic services such as public transit, healthcare, and legal aid; and
11	WHEREAS, Youth and their families are now afraid to report crimes, seek
12	protection, or ask for help, directly undermining public safety and weakening the trust
13	between communities and the institutions meant to serve them; and
14	WHEREAS, San Francisco's sanctuary city policies exist to promote safety and
15	unity, yet the presence and actions of ICE undermine these values and destabilize
16	neighborhoods that rely on consistent support and trust from their local government;

18	WHEREAS, In addition to the rise in ICE activity, the recent treatment of U.S.
19	Senator Alex Padilla, an elected official and the son of immigrants, has sparked concern
20	over the erosion of democratic norms; and
21	WHEREAS, Young people across the city are calling for dignity, accountability,
22	and lasting protections for immigrant communities who call San Francisco home; and

1	WHEREAS, We have seen this through the "No Kings" protests that occurred
2	across the nation, including San Francisco, on June 14th, 2025, where young people
3	protested the recent treatment of immigrants and the concerning deployment of the
4	National Guard; and therefore be it
5	MOVED, That the San Francisco Youth Commission strongly condemns the
6	recent and ongoing ICE raids, and the irreparable harm they are causing to immigrant
7	youth, families, and communities across San Francisco and the nation; and
8	FURTHER MOVED, That the Youth Commission reaffirms its unwavering
9	support for San Francisco's sanctuary city policies and urges all City departments,
10	especially those serving youth, to uphold these protections in both policy and practice;
11	and
12	FURTHER MOVED, The Youth Commission calls on the Mayor, the Board of
13	Supervisors, and all relevant city agencies to advocate against ICE raids and to invest
14	in programs that protect and empower immigrant youth and families during this budget
15	cycle.

Dear Mayor Lurie and Members of the Board of Supervisors,

The San Francisco Youth Commission is deeply disturbed by the recent escalation of Immigration and Customs Enforcement (ICE) activity that has sown fear and instability across San Francisco, Los Angeles, and various cities in our country. We stand firmly in support of the young people and families in all communities during these distressing times, including immigrant communities, that are the foundation of this city.

One instance of this occurred on June 4th, 2025, when, after appearing for an ICE check-in appointment, at least 15 individuals, including four children with the youngest being three years old, were taken into custody by ICE and brought to immigration detention centers. Arrests like these, made during routine check-ins, demonstrate ICE's escalating and unnecessarily aggressive enforcement tactics. These events contribute to the fear, instability, and trauma felt by immigrant families across the Bay Area and beyond.



The trauma caused by ICE raids—particularly to children and youth—has led to increased absenteeism in schools, disengagement from civic life, and fear of accessing basic services such as public transit, healthcare, and legal aid. Youth and their families are now afraid to report crimes, seek protection, or ask for help. This directly undermines public safety and weakens the trust between communities and the institutions created to serve them.

San Francisco's Sanctuary City policies exist to promote safety and unity, yet the presence and actions of ICE directly undermine these values, especially when ICE targets areas where immigrants go to access basic services and build community, such as schools, ICE check-ins, courts, and graduations. This destabilizes neighborhoods that rely on consistent support and trust from their local governments.

In addition to the rise in ICE activity, youth are concerned about the recent forced removal of U.S. Senator Alex Padilla, an elected official and the son of immigrants, leading people to question how the federal government is treating undocumented detainees and those who are speaking out against ICE. Furthermore, young people across San Francisco are concerned that the federal government's deployment of U.S. Marines and National Guard in response to protests in Los Angeles, demonstrate an overreach of power and the erosion of democratic norms. Lastly, Executive Order 14160 issued by the current presidential administration directly contradicts the 14th Amendment. This action—along with others targeting immigrant communities—reflects a troubling pattern of disregard for the United States Constitution.



While some youth are beginning to feel hopeless, others across the city are calling for dignity, accountability, and protections for our most vulnerable communities who call San Francisco home. For instance, during the "No Kings" protest on June 14th. 2025, young people across the nation, including those from San Francisco, protested the recent treatment of immigrants and the deployment of the National Guard by the current Federal administration. The Youth Commission supports peaceful protesting and exercising one's 1st Amendment rights. Please note that city officials, including the Mayor and District Attorney, have expressed that those engaging in unlawful activities will be prosecuted to the fullest extent of the law. Damaging city property or disrupting local government only sets our communities further back. In moments like this, we must come together, not divide—uniting our energy and resources to build a safer, more just San Francisco for everyone, especially immigrant communities. If any young person is being wrongfully detained, we urge you to contact the Youth Commission office immediately. We are committed to doing everything we can to support and advocate on their behalf.

The Youth Commission strongly opposes the recent and ongoing treatment of immigrants, which has caused irreparable harm to youth and their communities across San Francisco and the nation. The Commission stands behind San Francisco's sanctuary policies and urges all departments and agencies, especially those who serve youth, to uphold these protections in both policy and practice. We hope that the Mayor and Board of Supervisors will continue to advocate against inhumane practices and
