a. Community Outreach Report

Commissioner Yang met with MyPath, a community organization focusing on financial literacy programs and wanting to incorporate more hands-on experience in schools. Commissioner Fong met with someone from Generation Citizen about more civic engagement courses in schools. Chair Marlow spoke with BAYCS about getting more youth involved. Vice Chair Kim connected the Commission staff with Richmond Neighborhood Center.

b. Resolution Writing Working Session

The Committee discusses the resolution on bathroom locks and concludes that more research is needed. The Committee also looks over the resolution draft that Commissioner Yang started. There are suggestions about inviting SAC cabinet members to present to CEEC.

c. Budget and Policy Priorities

Commission staff talks about how BPPs are formatted. The Committee asks questions about the BPPs.

Vice Chair Kim suggests expanding the scope of the resolution that the Committee is working on, and Commissioner Fong suggests that the resolution should focus on school infrastructure broadly. Commission staff will reach out to SFUSD and their facilities manager to schedule a presentation to CEEC.

Potential BPP Topics

- Vote16 and Civic Engagement pieces have been consistently on the BPPs
- Marlow - Violence against teens
- Yang - drug education / curriculum, mental health services, climate infrastructure
- Kim - mental health, identity, and culture (curriculum and programs that are identity-affirming), AI

- Liang - voter registrations
- Fong - housing for teachers, john muir's math program/curriculum
