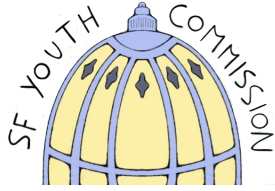
a. Review Talking Points

c. Goals for the end of 2023



Chair Alioto-Pier goes over the goals from a previous meeting. Commissioner Barker Plummer found a videographer for the documentary. The Committee will be starting the BPPs soon after reviewing the last term's BPPs.

The 22-23 BPP on Vote16 included talking points around cold cognition, more social and political access through social media, more representation in government, and the impact of decisions made impact youth in the future.

Planning for the Vote16 BPP

Points the hit:

- Licenses
  - 16 and 17-year-olds responsibilities, taxes, tried of adults
- Access to services -> smaller point
- Overall voter turnout -> habitual voters
- Decisions about the future of SF -> youth stakeholders

Chair Alioto-Pier is a little iffy about the cold cognition piece from last year's BPP, but Commissioner Barker Plummer suggests rewording it to, "Psychologists say the right time to begin voting..."

Skeleton of Vote16 BPP and Assignments

- Intro (History)
- Responsibilities - Marroquin
- Access to resources - Perez
- Right time to vote - Barker Plummer
- Overall voter turnout - Alioto-Pier
- Future of City - Barker Plummer
