Vice Chair Barker Plummer said that he appreciated how quick the April 3rd meeting was. Vice Chair Barker Plummer shared feedback from Chair Nguyen since she isn't able to be present for the meeting.

6. Business (all items to follow discussion & possible action)

a. Review Commission Attendance

Director Garcia said the only urgent matter is regarding Commissioner Im's absences for the Civic Engagement and Education Committee, since she has now maxed out the allowable amount of absences. She will be considered to have resigned from CEEC at the following meeting since she will not be present for the special hearing with the Board of Supervisors' Youth, Young Adult, and their Families Committee later this month. Staff will discuss next steps and a new committee to join for Commissioner Im in the coming weeks.

b. Updates on Commission Outreach and Communications



- i. Presenters: Gabrielle Listana & Astrid Utting, Communication and Outreach Officers

Officer Listana and Officer Utting are working to schedule presentations with school teachers in SFUSD. Chair Nguyen also asked in her notes for the 2023/24 recruitment flyer to be less wordy and to create a flyer for the virtual information session for April 19th.

- c. Updates on Recent Youth-Related Board of Supervisors/Mayor Legislation
 - i. Presenters: Steven Hum & Raven Shaw, Legislative Affairs Officers

Officer Hum said he wasn't able to make it to the previous LAO Check-In with staff. Staff reported which legislation the Youth Commission is currently reviewing for comment including the police overtime funding, San Francisco general plan amendment with the climate action plan, the Safer Schools Task Force, the human trafficking report, and several others. Specialist Zhan also said there are several upcoming hearings that the Youth Commission will be engaging in.

- d. Debrief of Budget Presentation to BOS Budget & Appropriations Committee

Vice Chair Barker Plummer said that the budget presentation went well, but that it could be shorter and more of a general overview in the future. He added that the presentation should be around 30 to 45 minutes, instead of around the hour it took on March 22nd.

- e. Youth Budget Town Hall Recap

Vice Chair Barker Plummer said he appreciated how well it went and the LGBT Center for hosting our event. Officer Utting said the presentation should probably be shorter to allow more discussion and listening from the public, and that the icebreakers should be towards the beginning to build a broader community vibe. Officer Utting said that she would prefer that we create a more intimate setting like Manny's or a similar location. Officer Listana said she thought it went well, and that the biggest topics she heard was about school safety and support for neurodivergent youth. Vice Chair Barker Plummer said that the biggest topic that came up for them was queer and trans youth homelessness, and he would love for them to attend. Staff also gave their feedback on the event.

- f. Outreach and Distribution of BPP Reports



Specialist Zhan said that she has distributed the BPPs to all of the Board of Supervisors' offices, and their legislative aides have already been reviewing them and giving feedback. Director Garcia said she will be distributing them to the Mayor's Office soon. Specialist Ochoa said that he is putting together a distribution list of all of the city departments and community-based organizations, and they hope to be sent out by the Clerk's Office by the end of this month.

g. Youth Commission Recruitment

Staff have been working on sending out the recruitment flyer to community partners and organizations. Vice Chair Barker Plummer said that the sooner the YC can get the recruitment flyer posts up, the better. Director Garcia said staff would also be meeting with current commissioners to see who intends to apply for re-appointment next year, and who wants to help with the interview process. Specialist Ochoa said he will be printing out flyers for commissioners to distribute individually at the next full Youth Commission meeting.

h. Approval of Full YC April 17, 2023 Agenda

Vice Chair Barker Plummer amended the agenda to remove Items 7-10, which includes Letters of Support, Resolutions and Motions, Committee Reports, and Roll Call and Introductions, due to time constraints with the hearing and other pressing agenda items.
