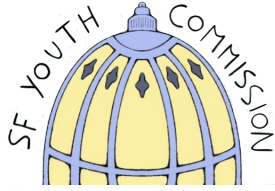

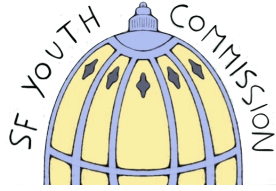

[Support Assembly Bill (AB) 2591: Local government: youth commissions]

**Motion supporting AB 2591- Youth Commissions in Local Governments and urging the Mayor, Board of Supervisors, and San Francisco’s members of the State Legislature to support.**

WHEREAS, AB 2591, introduced by State Assemblymember Sharon Quirk-Silva will require counties and cities to establish a youth commission in response to petitions from youth residing in their jurisdiction; and

WHEREAS, The bill will allow for the submission of a youth petition requesting the board of a county to establish a county youth commission of the board; and

WHEREAS, AB 2591 allows for youth to be involved in decision making at the local government level; and

WHEREAS, Young engagement can lead to increased academic performance and improved social-emotional well-being; and

WHEREAS, Youth are our future and we should foster their desire to be involved to assist their communities; and

THEREFORE BE MOVED, That the San Francisco Youth Commission urges the San Francisco Board of Supervisors and Mayor London Breed to support Assembly Bill 2591.

On behalf of the San Francisco Youth Commission, we are writing to express our support for bill, AB 2591 (Quick-Silva). AB 2591 would enhance youth civil engagement in California local governments by allowing cities and counties to establish a youth commission.

The Youth Commission is a body of 17 youth from San Francisco between the ages of 12 and 23. Created by the voters under a 1995 amendment to the City Charter, the Commission is responsible for advising the Board of Supervisors and the Mayor on policies and laws related to young people. The Youth Commission is also charged with providing comments and recommendations on all proposed laws that would primarily affect youth before the Board of Supervisors takes final action.

The Youth Commission has been successful in engaging youth in local government advocacy and establishing efforts such as free public transportation initiatives to youth under the age of 19, lowering the voting age to 16 in municipal elections, and working with city departments to focus transitional youth efforts. The Youth Commission has been the main bridge builder between youth serving organizations and elected officials in San Francisco. Over the last 29 years, the commission has grown into a hub of civic engagement and youth power in government.

The Youth Commission further encourages other areas across California to start their own commission and get more youth civically engaged in local government.
