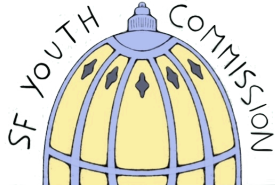

a. Community Builder

Officer Lonné Amir asked "if you invested an ice cream flavor, what would it have and what would it be called". Commissioners and staff answered.

b. Review Commission Attendance



Director Garcia gave the Commission's attendance report, and said that only one commissioner should be kept aware of to ensure they're attending their meetings.

- c. Updates on Commission Outreach and Communications
  - i. Presenters: Téa Lonné Amir & Kelly Wu, Communication and Outreach Officers

Officer Wu said the information sessions went well and the audience was very receptive to their presentations. Officer Lonné Amir said that the Cherry Blossom Festival tabling went well, and that the Instagram takeovers are going well. Officer Wu asked if the YC promotion video should be posted onto Instagram, to which staff said yes and that they will put it on the YC's YouTube.

Specialist Ochoa let the committee know that there are currently 11 applications that have been submitted, which is higher than the previous trend from last year, but that everyone should be pushing these last few days to ensure we increase the amount of applicants for this year.

- d. Updates on Recent Youth-Related Board of Supervisors / Mayor Legislation
  - i. Presenters: Allister Adair & Jason Fong, Legislative Affairs Officers

Officer Fong said BOS File 240389 [Hearing - Status of City Departments Handling Criminal Sexual Assaults and Sexual Harassment Allegations] will be referred to the May 6th full Youth Commission meeting. Officer Fong added that BOS File 240367 [Ordinance - Approving the Surveillance Technology Policy for the San Francisco Municipal Transportation Agency (SFMTA) use of Automated Speed Enforcement System], BOS File 240388 [Hearing - City's budgetary decisions regarding funding of essential City services that prioritize caregiving and economic security, including early childhood education, family, and youth-serving programs and resources, and support of economic security and initiatives reaching low-wage, immigrant, and nonprofit workers; and requesting the Department of Early Childhood, Office of the City Administrator, and Office of Labor Standards Enforcement to present], and BOS File 240427 [Hearing - City's budgetary decisions regarding funding of essential City services that prioritize community safety and wellbeing, including community programs that prevent crime, provide family, youth, and TAY (transition aged youth) services, and support the City's immigrant and limited English Proficient residents; and requesting the Department of Children, Youth, and their Families, Mayor's Office of Housing and Community Development, Office of Economic and Workforce Development, and the City Administrator's Office of Civic Engagement and



Immigrant Affairs to report] will all be referred to the May 20th full Youth Commission meeting.

Officer Fong also mentioned that committees will be discussing and practicing doing public comment to the Board of Supervisors to advocate for youth priorities. Chair Barker Plummer mentioned that he will be able to do more public comment now that his USF school year is coming to an end.

Specialist Ochoa introduced an idea for Youth Commissioners and staff to hold a listening session for community-based organizations to hear the concerns from CBOs regarding the recent major budget cuts from the Department of Children, Youth, and their Families' (DCYF) requests for proposals (RFPs). Chair Barker Plummer said he is in support of this listening session, and that he believes this can help compile all of the concerns in one place instead of many YC presentations. Commissioners were in support of having this listening session, and asked them for data and statistics on how these budget cuts will hurt San Francisco youth.

- e. Motion No. 2324-AL-18 Motion to Support Assembly Bill 2591: Youth Commission in Local Government and urge the San Francisco Board of Supervisors and Mayor London Breed to support AB 2591

Director Garcia introduced a motion and letter of support for the statewide AB 2591 legislation, and to empower youth voices statewide as a long-standing youth commission comparable to other regions of the state and nation. Chair Barker Plummer said he would author, and that Vice Chair Listana and Officer Fong asked to be added as co-sponsors.
