Officer Valencia-Tow wants the commission to do more public comment and get more public engagement when it comes to public comment.

Chair Fong agrees with doing more public comment and added we need to do more action in front of the BOS. Acknowledge we haven't been as active and forward facing to the BOS since the pandemic. Making sure the BOS knows where we stand on youth issues and work the commission is currency working on.

Officer Valencia-Tow is excited for the BPP process and engaging youth/non-profits in the process. Doing more in the budget process.

Officer Yang would like to see 2-3 commissioners at each community event. And making sure we are showing up to different events.

Officer Fong would like to see commissioners be more engaged with BOS offices and different non-profits on issues facing their district and on current legislation.

Officer Valencia-Tow wants to check in on the D7 youth council and see how the commission can support them.

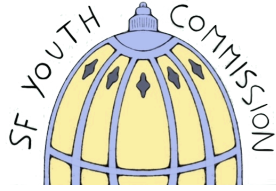

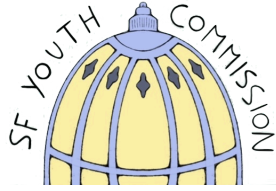
