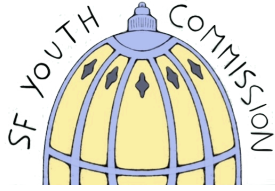

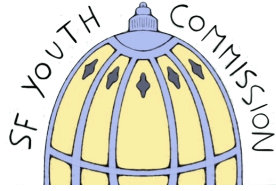

Language Access Ordinance), and requesting community organizations who provide language access to present feedback; and requesting the Office of Civic Engagement and Immigrant Affairs to report.

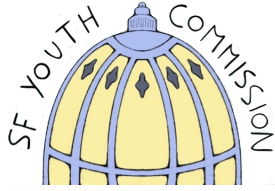
i. Presenter: LAOs

Officer Adair introduced the item, and said that there is about two weeks for any commissioners to submit questions and comments, and submit to the hearing. Officer Lonné Amir asked about specifics in regards to how people access the language access services in the first place. Commissioner Stack Lozano said that most of people's experiences were negative in retrieving information, and they should look deeper into that. Officer Adair said he'd like to find out more information and data in regards to youth when it comes to language access. Chair Barker Plummer said he has the question regarding the retention of the services, and the impact of youth translation for their families. Vice Chair Listana read aloud the six questions she has for the hearing, and submitted them to staff. Commissioner Faagau-Noa asked about the accessibility for language access resources that only exist out of their district or neighborhood.

BOS FILE NO. 240211 [Umbrella Memorandum of Understanding - SFPUC - SFUSD - Installation, Operation and Maintenance of Green Infrastructure] Resolution approving the Umbrella Memorandum of Understanding between the San Francisco Public Utilities Commission (SFPUC) and the San Francisco Unified School District (SFUSD), and establishing a partnership framework for SFPUC's installation and operation of various green infrastructure projects on SFUSD properties, with a total term of 40 years from June 1, 2024, through June 30, 2064, pursuant to Charter, Section 9.118.

BOS FILE NO. 240239 [Resolution urging Department of Homelessness and Supportive Housing to Develop a Comprehensive Plan that Prioritizes Families with Children to Receive Shelter] Resolution urging the Department of Homelessness and Supportive Housing to prioritize families with children to receive shelter or hotel vouchers the same day that they arrive at an access point, to develop a comprehensive plan that focuses on children and families to prevent children from living on the streets and develop a multilingual, accessible public dashboard where families can monitor the waitlist and the progress of moving families into permanent housing.
- i. Presenter: LAOs

Officer Adair said that he strongly believes that they should pass this to ensure that no youth spends the night on the street if they can't find housing when their voucher expires. Officer Fong added that he believes that all services should be accessible via language for the same reason. Chair Barker Plummer said it may be worth looking into complicated custody situations with minors, to which Commissioner Ye said that there's plenty of programs that deal with youth as of now that deal with minors. Officer Adair said it would be a good idea to prepare a public comment statement, and the HRT Committee could work on any questions or comments for the hearing. Officer Fong said that it would be important for HSH to recommend declaring a state of emergency regarding our street situations, to which Chair Barker Plummer said that they should look at the City Charter on the details of that.

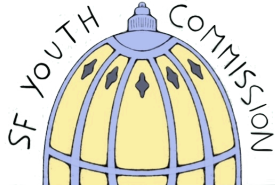

He added that they presented to the BOS Budget & Appropriations Committee last week on Wednesday, and they expressed their intent to see them more often. Officer Adair said that he hopes every commissioner is able to take a selfie with their appointing officer or their legislative aide.

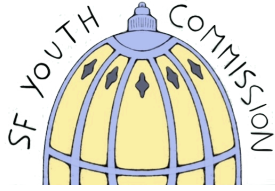
ii. Communication and Outreach Officers

Commissioner Barker Plummer said he attended the Easter on the Beach event this past weekend, he strongly encouraged the promotion of the new YC application for the upcoming term, he has been doing community outreach and planning for Vote16, he said the YC officers presented to the BOS's Budget & Appropriations Committee, and said he would be working on various issues or resolutions with other commissioners.

Commissioner Listana said she has been doing outreach regarding Vote16 education within the Tenderloin and other Filipinx organizations, she recorded the first episode of the YC Podcast with Chair Barker Plummer last week, and said if anyone is interested in being on the podcast with any ideas they have to reach out to her as soon as possible.

Commissioner Adair said he's been preparing to do public comment for the budget process later in June, he said he went to a YMCA panel event that was about middle schoolers who put together policy proposals, and he hopes to work more on resolutions within the HRT Committee.

Commissioner Fong said he's working on a resolution on subway surfing, and he's been doing Vote16 outreach and presentations.



Commissioner Wu said she's been doing Vote16 outreach, talking to more of her classmates about the application for the Youth Commission, and she was able to talk with D3 youth at a fun science-themed event.

Commissioner Lonnè Amir said she attended the Easter on the Beach event last weekend with Chair Barker Plummer, and she's been referring friends and other youth to apply for the Youth Commission.

Commissioner Ye said she was able to attend the Easter on the Beach event as well, she will be meeting with young people at her school to encourage them to apply to the Youth Commission, and met with a SFPUC local leader to discuss water access, Hetch Hetchy, and soda tax recruitment.

Commissioner Alioto-Pier said she's been working on Vote16 outreach.

No other introductions.

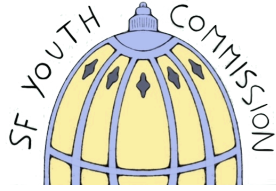
Officer Fong left the meeting at 6:15pm, and returned to the meeting at 6:18pm.
