Alarming instances of poor judgment and traumatizing drills have put a light on the unregulated structure of guidance that schools and local educational agencies have to navigate when devising these types of drills. It has been observed that extreme versions of these drills cause trauma for students and have questionable benefits in active shooter situations. It is essential that active shooter drills serve the purpose of preparing students and educators for emergencies, not create fear and trauma which can make these drills ineffective.

AB 1858 would create a permissive and structured procedural guidance to be available through the California Department of Education that is focused on preparedness, open communication, and minimizing the trauma that currently is caused by school shooter drills.

For these reasons, the San Francisco Youth Commission supports AB 1858.
