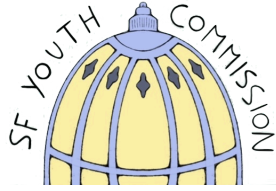
Alondra Esquivel Garcia, Director of the SFYC, shared communications and meeting announcements with Commissioners.

Commissioner Ansari, seconded by Commissioner Perez, motioned to approve Resolution No. 2324-AL-17. Discussion:

Commissioner Ansari mentioned that the language around the survey was removed, along with other minor language changes. Chair Barker Plummer said he wants to relay the concerns brought up by the public commenter at the last meeting regarding the frustrations around the current direction of the "Welcoming West Portal Committee". Officer Fong mentioned that he attended the committee and felt comfortable that the stakeholders would be able to come up with a solution to all of the concerns that've been brought up. Fong added that the dialogue at the most recent meeting was very helpful in addressing concerns of those in the neighborhood from the initial community input draft by SFMTA.

- b. **RESOLUTION No. 2324-AL-20** Resolution urging the Mayor and Board of Supervisors to review and amend the proposed funding allocations to youth-serving nonprofits and community-based organizations from the Department for Children, Youth, and Their Families to maintain current services for youth and mitigate budget reductions (First Reading)
- i. Presenter(s): Commissioner Barker Plummer

Chair Barker Plummer, seconded by Commissioner Faagua-Noa, motioned to suspend Article IX, Section C of the Bylaws. Discussion:

Chair Barker Plummer introduced the resolution and stated the reasoning for putting together a resolution to support refunding many of the community-based organizations that are facing massive budget cuts from the City. He mentioned that the power to change this is currently in the Mayor's hands before she proposes the budget to the Board of Supervisors on May 31st.

Officer Fong added that many of the organizations he has been familiar with and many of the community-based organizations that will suffer because of the cuts.

Commissioner Ye thanked both Chair Barker Plummer and Officer Fong for their work on the language, and she hopes to see DCYF and the City adjust these numbers to support the important work that organizations are doing, and not create a monopoly of youth-serving programs.



Vice Chair Listana thanked the authors and brought up the critical funding for youth programming that supports marginalized youth, and the harm that will come to those communities if the organizations aren't funded.

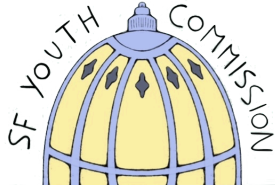

- d. **BOS File. No. 240367** - Ordinance (Administrative Code - Surveillance Technology Policy - Automated Speed Enforcement System - SFMTA) Ordinance approving the Surveillance Technology Policy for the San Francisco Municipal Transportation Agency (SFMTA) use of Automated Speed Enforcement System.
- i. Presenter: Legislative Affairs Officers Jason Fong and Allister Adair

Officer Adair stated that this legislation is already further along the process so they can't take a position of support at this time, but wanted to inform the Youth Commission on the legislation. Officer Fong added that this would allow for the use of surveillance technology for automatic speed traffic enforcement.

Commissioner Ye said that her main concern is where the speed safety cameras are being placed and why, to which Officer Adair said that all 33 cameras will be placed across the high-injury network and near school sites.

- a. Executive Committee



i. Legislative Affairs Officers

Officer Adair said that besides the item on today's agenda, there was no other legislation referred to the Youth Commission. He added that he would love to see as many commissioners as possible to do public comment on 'Public Comment Day' on June 24th.

ii. Communication and Outreach Officers

Officer Lonné Amir said there were no major updates.

iii. General Committee Updates

Chair Barker Plummer said that Vice Chair Listana was not present due to an "ailment". He said that the meeting went well as he was chairing in Vice Chair Listana's place.

Commissioner Perez said CEEC discussed what would be their top priorities moving forward with a recent report.

c. Housing, Recreation, and Transit Committee

Officer Fong said HRT worked on amending the West Portal resolution, as well as potential future action on housing LGBTQ+ youth and youth in general to attain supportive housing services.

d. Transformative Justice Committee

Commissioner Dang said that TJ didn't meet, but that members are working individually on narcan distribution work.

Commissioner Faagau-Noa said there is a scholarship program that prioritizes youth who live in the Bayview that other commissioners should spread the word for.

Chair Barker Plummer said that he will be on a panel on gun violence in collaboration with the SF Opera on May 31st. He added that there is the March Against Gun Violence across the Golden Gate Bridge on June 1st, which commemorates the lives that were lost due to gun violence, and to wear orange.
