Commissioner's spoke about different outcomes and resolved clauses they want to see. Commissioner's agreed to work on the resolution alongside their budget and policy priority on immigration. Chair Dang expressed the importance of the resolution and continuing to do research on the topic.

Director Esquivel Garcia will look into immigration/sanctuary policy and how it affects young people in Juvenile Hall.

Chair Dang gave an overview of the timeline for BPP's . Chair Dang expressed that February 6th is when first drafts are due. Director Esquivel Garcia will reach out to city departments for answers on various questions. Commissioners checked on the different topics they are writing about.
