The San Francisco Youth Commission's Transformative Justice Committee met in-person on February 12, 2024 with Chair Ye presiding.

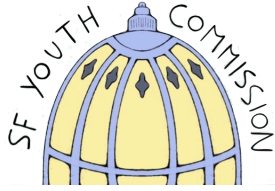
1. Call to Order and Roll Call for Attendance

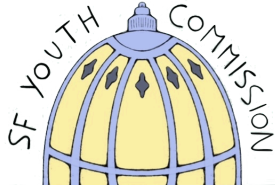

Teen Violence Prevention Month Resolution - Update

Budget and Policy Proposals (BPP) Discussion

Language Access BPP

The Committee reads the BPP into record. Commissioner Listana notes that the one the Committee is reading is the old one from last year. The Committee moves onto the next BPP.

The Committee revisits the correct BPP and reads it into record. Commissioner Lonné Amir asks about the places in the BPP that need to be linked. Vice Chair Dang asks about the Tagalog Instructions in schools.

Fetenayl Overdose Prevention

The Committee reads the BPP into record. Chair Ye asks for clarifications on what a “drug alert” is. Chair Ye suggests adding a section about “YC Involvement”. Vice Chair Dang suggests adding the pricing of narcan. Commissioner Faagau-Noa suggests adding a picture of what narcan is.

Food Insecurity

Commissioner Listana summarizes the BPP and goes over the recommendations. Chair Ye recommends formatting and adding some pictures.

Chair Ye notes that the Juvenile Hall BPP is dropped from this year’s report because there are no new actions and information regarding the situation at juvenile hall.

Bayview Environmental Effects

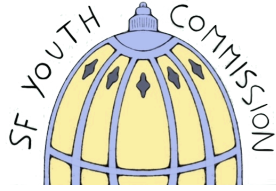
Suggestions were made to add footnotes, pictures, and effects the oil has on residents.

Commissioner Lonné Amir asks about the SFCASA event.

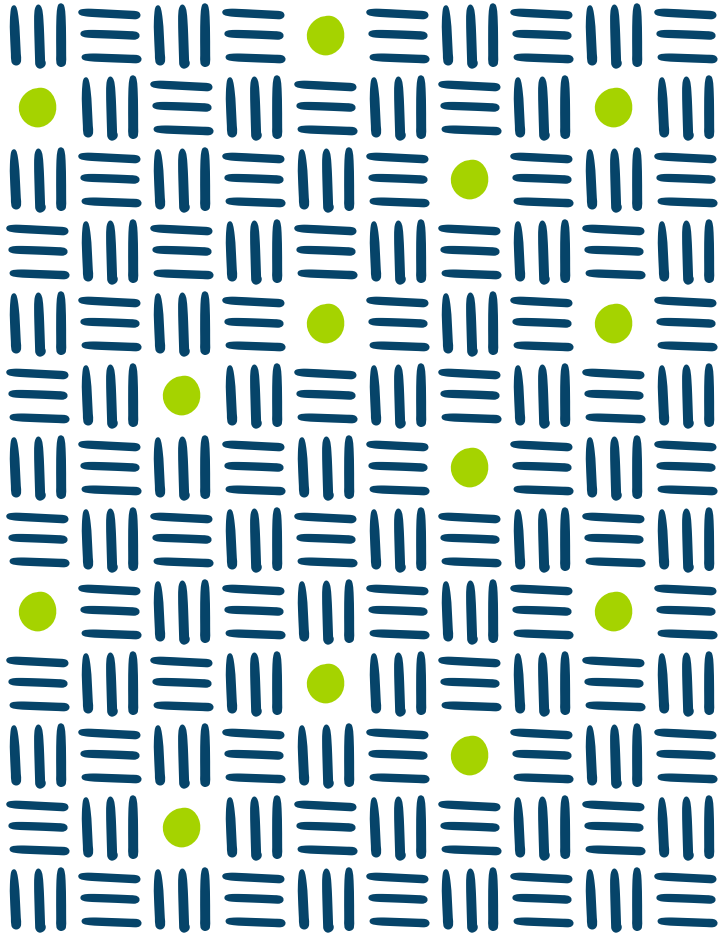


7. Announcements (including Community Events)

Ms.Zhan asks the Committee to pass out the Youth Budget Community Forum flyers at schools and in their neighborhoods.

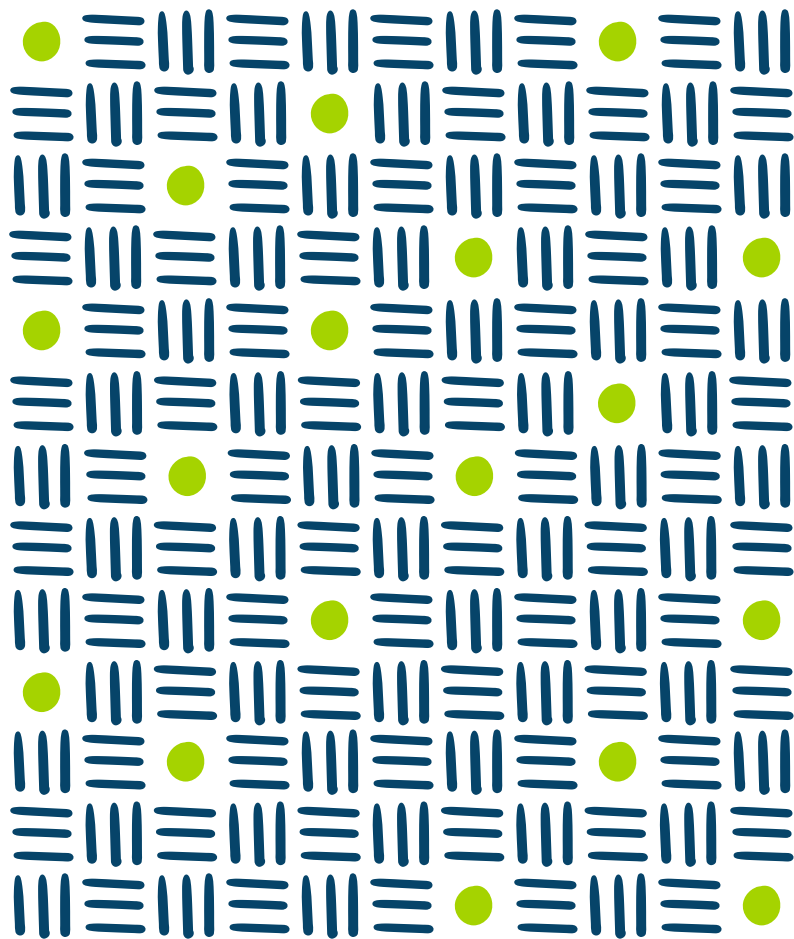
8. Adjournment

A.B.-2108

A.B.-2108 Foster care: missing children and nonminor dependents. (Luke Madrigal Act)

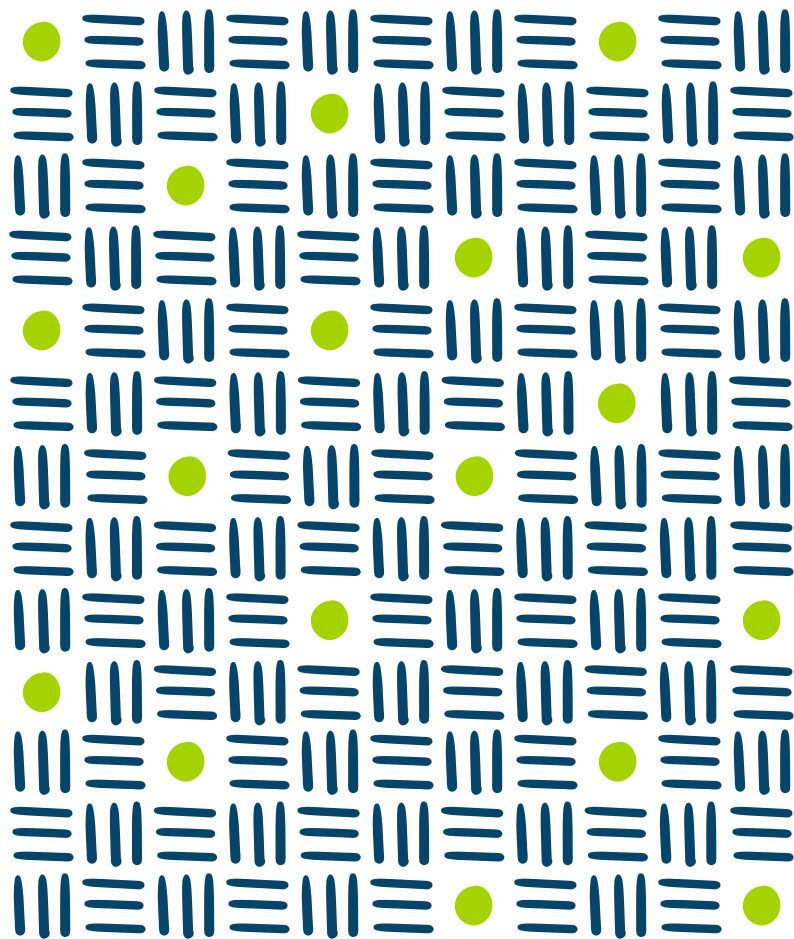
- **Existing Law**
 - County child welfare agencies and probation departments develop & implement specific protocols to locate any child or nonminor dependent missing from foster care
- **What this bill does**
 - Additional requirements for social workers and probation officers dealing with children in foster care
 - Notify law enforcement and the child's parents/guardians, within 24 hours of learning that a child receiving child welfare services is absent from foster care



A.B.-2108 Foster care: missing children and nonminor dependents. (Luke Madrigal Act)

- The term "absent from foster care"
 - When the child's whereabouts are unknown to the relevant agencies
 - When the child is found in an unapproved location that may pose a risk
- "child receiving child welfare services"
 - Those in specific foster care placements, emergency caregiver homes, or those taken into temporary custody

A.B.-1186

A.B.-1186 Bonta. Juveniles: restitution

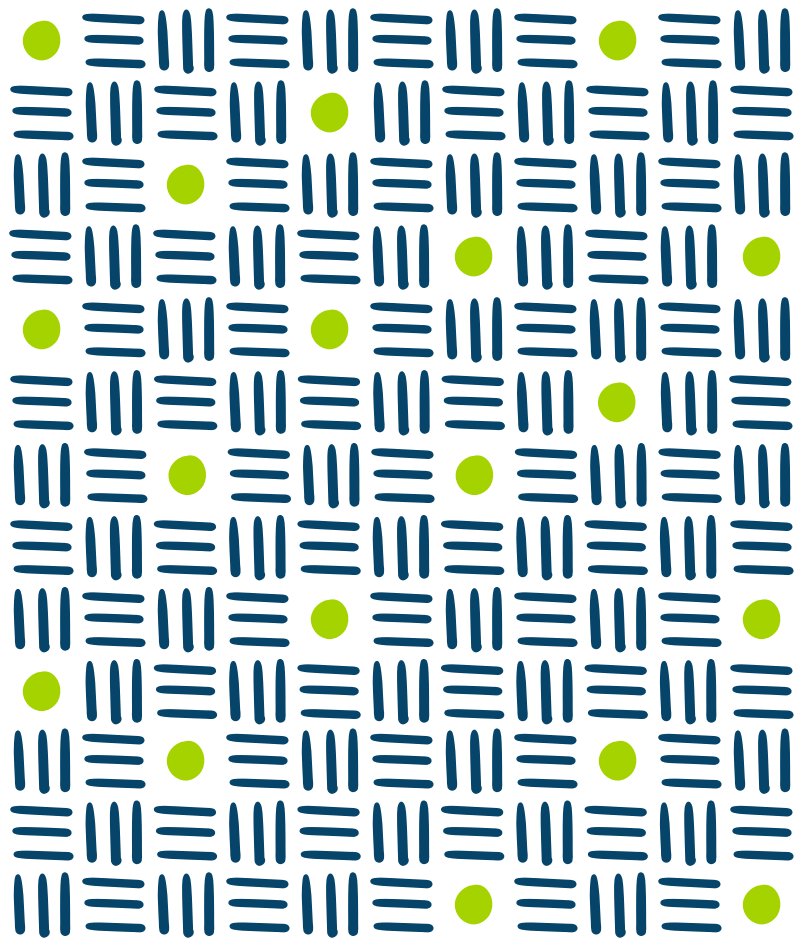
- **Existing Law**
 - Authorizes a court, upon adjudicating a person to be a ward of the court, to require the minor to pay restitution to the victim or victims
- **What this bill does**
 - Remove the ability of the court to require the minor to pay monetary restitution to the victim
 - Require the court to determine the amount of economic loss suffered as a result of the minor's conduct and issue a restitution order
 - California Victim Compensation Board to compensate the victim for the amount in the order



A.B.-1186 Bonta. Juveniles: restitution

- The bill would authorize the court to instead order the minor to make non monetary restitution by participating
 - community-based restoration program
 - performing community service
- OR
 - educational employment
 - youth development
 - mental health program
- The majority of youth simply cannot afford to pay restitution
- Hold a young person responsible for their actions while also setting up both young people on a more economically secure path

A.B.-2411

A.B -2411 Wendy Carrillo. Local Youth Mental Health Boards.

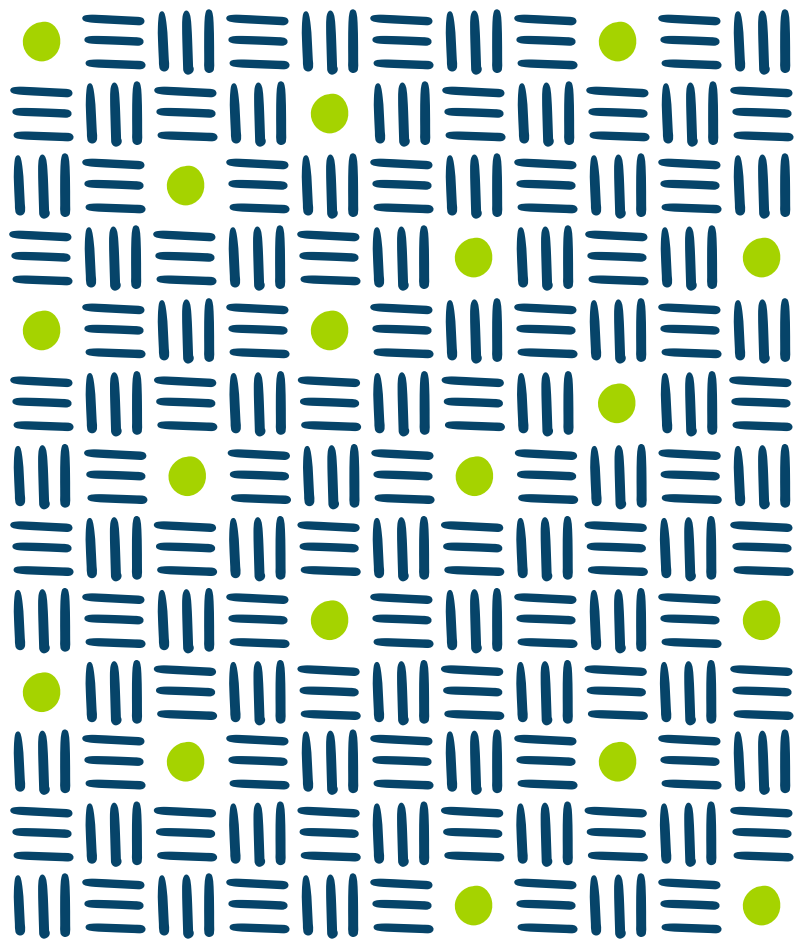
- **Existing Law**
 - Contains provisions governing the operation of community mental health services in every county through locally administered and community mental health programs
- **What this bill does**
 - Require each community mental health service to have a local youth mental health board
 - Consisting of youth from 15 y/o-23 y/o
 - At least 1/2 of whom are mental health consumers who are receiving, or have received, mental health services
 - At least 1/2 of whom are enrolled in schools in the county



A.B -2411 Wendy Carrillo. Local Youth Mental Health Boards.

- Responsibilities of the board
 - To review and evaluate the local public mental health system
 - Advise the governing body and school district governing bodies on mental health services related to youth
 - Provide a budget for the board sufficient to facilitate the purposes, duties, and responsibilities of the board





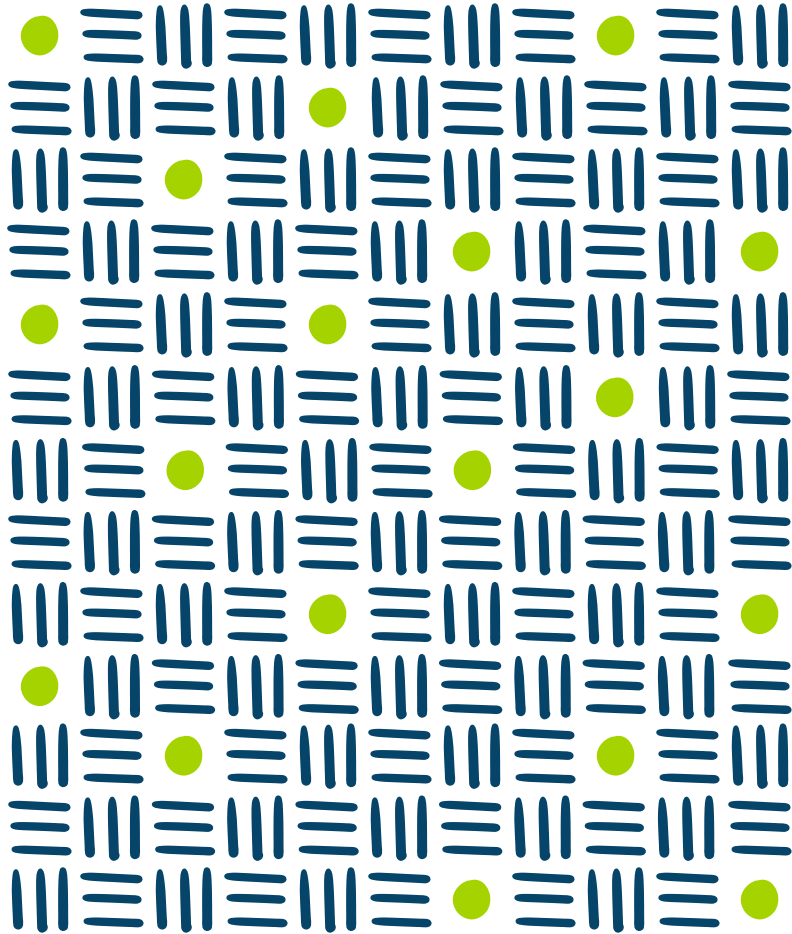

A.B.-1887

AB-1887 Foster care: LGBTQ youth.

- **Existing Law**
 - Provides for the placement of foster youth in diverse settings and oversees the delivery of child welfare services
- **What this bill does**
 - Require the department to assemble a workgroup tasked with generating a report containing recommendations aimed at preventing housing instability among LGBTQ youth in foster care
 - The bill would require the workgroup to submit that report on or before January 1, 2026
 - Overall, 28% of LGBTQ youth reported experiencing homelessness or housing instability at some point in their lives





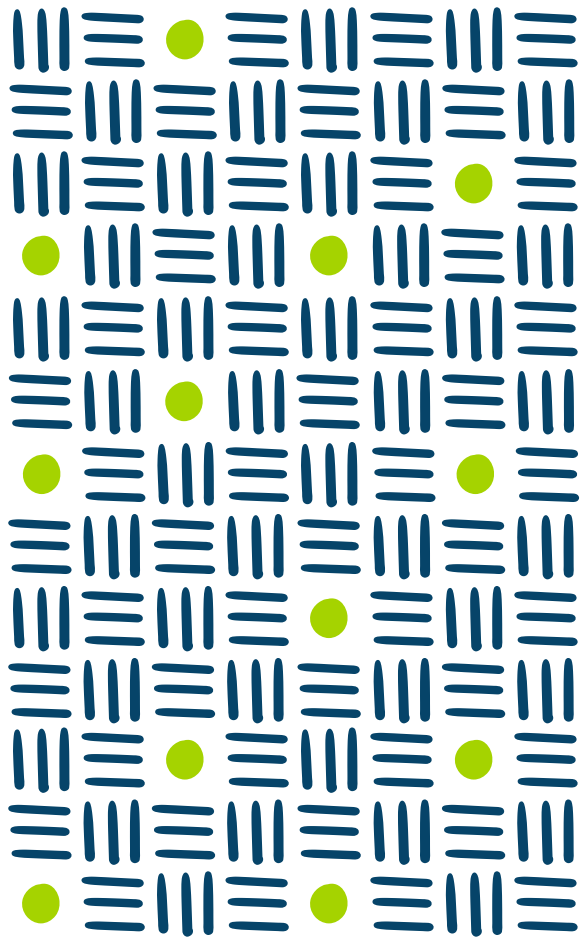

S.B.-953

S.B.-953 Medi-Cal: menstrual products.

- **Existing Law**
 - Establishes the Medi-Cal program, which is administered by the State Department of Health Care Services , qualified low-income individuals receive health care services
- **What this bill does**
 - Would add menstrual products to that schedule of covered benefits
 - Require the department to seek necessary federal approvals to implement this coverage
 - Would authorize the department to use, any and all available federal funding, to implement this coverage
