The San Francisco Youth Commission's Transformative Justice Committee met in-person on June 10, 2024 with Chair Ye presiding.

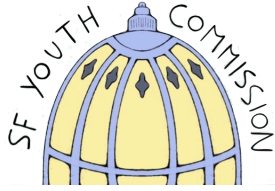
**1. Call to Order and Roll Call for Attendance**

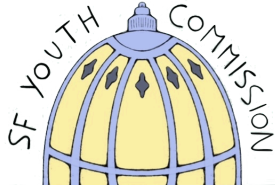

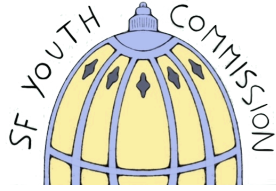
### **DCYF Human Trafficking Advocacy Conversation**
